HOW WE GOT HERE

CEO Matlock gave an overview of LPEA's process on the RFP (Request for Proposals) vendor selection, agreement, and the committee recommendation.

VP Harms presented slides on the partial requirements RFP and analysis. The objective of the meeting is to select a power supplier with whom to negotiate LPEA's MAX Purchased Power Agreement (PPA). This agreement will allow LPEA to continue to negotiate with one provider out of the three selected.

Staff's recommendation is to enter into further negotiations with Supplier 2 on a PPA to secure LPEA's MAX Partial Power Supply. VP Harms, and CEO Matlock fielded questions from LPEA directors.
