QUESTIONS ON JANUARY FINANCIALS

As there was no FAC meeting in February, the committee members were invited to ask any questions regarding the January 2022 financials that were not addressed at the February meeting of the LPEA Board of Directors. VP of Finance Ramsey was available to field questions; no questions were posed.

FEBRUARY FINANCIAL UPDATE

VP Ramsey addressed the preliminary February financial statements. Gross margin was significantly over forecast due to a combination of higher kWh sales and a high load factor. Controllable expenses were slightly below forecasted levels, resulting in strong operating margins. All the board's financial goals were met at the end of February except for cash, although the balance had grown during the month and was higher than at the end of January. As of the date of the FAC meeting, cash reserves were over 16% of annual budgeted expenses.

COST OF SERVICE ANALYSIS REVIEW

VP Ramsey reviewed the highlights and changes made to the Cost-of-Service Analysis (COSA) presentation since it was last brought to the committee by EES Consulting in January. VP Ramsey and VP of Grid Solutions Harms answered questions from the committee members. It was agreed that no action would be recommended to the full board regarding the COSA.

EXECUTIVE SESSION

Committee Chair Lynch addressed the next item on the agenda to move into executive session.
