QUESTIONS ON OCTOBER AND NOVEMBER FINANCIALS

VP of Finance Ramsey was available to field questions; no questions were posed.

DECEMBER FINANCIAL UPDATE

VP Ramsey addressed the draft December financials. All financial goals were met in December. Operating margins were \$2.5m below budget due to the \$2.75m increase to the rate stabilization fund. Both residential and industrial sales were above forecast, and controllable costs were \$183k under budget. VP Ramsey took questions from the committee on the December financials.

AUDIT UPDATE

VP Ramsey gave an update on the audit conducted by Forvis, LLP (formerly BKD, LLP). The interim audit work was conducted virtually in November. Forvis, LLP will be reviewing results at the end of January and into the beginning of February in person. The final audit report will be presented to the full board at the March or April board meeting. VP Ramsey took questions regarding the audit update.

EXECUTIVE SESSION

Committee Chair McWilliams requested a motion to move into an executive session to discuss the direct assignment of transmission assets and other rate issues and an update on the three-prong strategy.
