APPROVAL OF AGENDA

Committee Chair McWilliams addressed the June 7, 2023, Finance and Audit Committee (FAC) meeting agenda.

APPROVAL OF MEETING MINUTES

BUDGET TIMELINE

VP of Finance Ramsey addressed the 2024 budget timeline. VP Ramsey reviewed the key concepts and explained LPEA's activity-based and zero-based budgeting approach. VP Ramsey took all questions from committee members.

NET METERING PROPOSAL OVERVIEW

EVP Harms informed the committee that the proposed changes to net metering policies and procedures were presented at LPEA's June 1, 2023, Solar Install Meeting. EVP Harms presented the group with the three proposed changes. First, limit the Net Metering Tariff to systems under 25 kW and develop a new Qualifying Facilities Tariff for systems over 25 kW. Second, implement an application fee to offset expenses LPEA is currently absorbing. Third, allow aggregated net metering, which would allow members to combine electrical meters of the same owner on the same or contiguous property. Feedback from the Solar Installer Meeting was reviewed. The committee confirmed that the 25-kW limitation to net metering should remain and that a single Qualifying Facilities rate at voided cost should be established. EVP Harms took questions from the committee and will send the proposed redlined Net Metering Tariff to the committee for review and to set a future effective date. EVP Harms will also set up a future lunch and learn for the full board to discuss the proposals.
