Committee Chair Wheeler addressed the August 10, 2023, Finance and Audit Committee (FAC) meeting agenda.

Committee Chair Wheeler addressed the July 13, 2023, FAC meeting minutes.

JULY FINANCIALS REVIEW

Karl Ramsey, Financial Consultant, gave an overview of the July financials. Most of the board's financial goals were met in July. The cash reserves were approximately \$3M below the board's target, this is due to a quarterly debt payment. Cash reserves are anticipated to be back to 12% by next week. Ramsey also addressed the income statement in detail. CEO Matlock and VP Ramsey answered questions regarding the July financials.

BUDGET UPDATE

Elizabeth Howe, VP of Business Services gave an update on the 2024 budget. VP Howe reviewed the key concepts and explained LPEA's activity-based and zero-based budgeting approach as developed by the VPs of each department. The first draft budget review will be at the FAC meeting in September. VP Howe, CEO Matlock, and EVP Harms took questions and suggestions on budget numbers.

REVIEW OF NET METERING (NM) AND QUALIFYING FACILITY (QF) TARIFF

EVP Harms gave a brief update on the Net Metering (NM) and Qualifying Facilities (QF) tariffs.

EVP Harms set up solar installer meetings to go over and obtain feedback on the final draft of the proposed Net Metering Rate Tariff. EVP Harms presented the solar installer feedback to the committee for their consideration and took questions and suggestions from the committee.

MOTION: Committee Chair Wheeler moved to recommend to the full board that LPEA post the proposed

Net Metering (NM) and Qualifying Facilities (QF) rate tariffs for a 30-day public comment period

in accordance with Policy 364. Motion seconded and carried without dissent.

EXECUTIVE SESSION TO DISCUSS BROADBAND PARTNERSHIPS

Committee Chair Wheeler requested a motion to move into an executive session to discuss broadband partnerships.

MOTION: Committee Member Matlock moved to enter an executive session to discuss broadband

partnerships. Motion seconded and carried without dissent.
